D'61 Special Class Officers/Executive Committee Virtual Teleconference

April 5, 2022

Maynard Wheeler, Class President, called the meeting to order at 3PM (EDT).

Maynard then reiterated that the purpose of this special virtual meeting was to obtain an update from Don O'Neill and Vic Rich, the two members designated as the '61 liaisons to the Dartmouth Presidential Search Committee, as to what transpired at the two virtual Zoom listening/discussion sessions held to date between the two designated representatives from each of the alumni/ae classes with the two Dartmouth trustee leaders of the Presidential Search Committee and then to discuss what thoughts the '61 class officers and executive committee members had with respect to the process, the content, and the end result of what was expected from the search committee by June 30, 2022, the end of the College's current fiscal year and the effective date of current President Hanlon's resignation.

Vic and Don reported that the meetings, each lasting approximately one hour or so, were moderated by Cheryl Bascomb, Dartmouth's Vice-President for Alumni Affairs. The content of the meetings was based less on the currently existing situation at Dartmouth and what we alumni/ae from the different classes view matters from its perspective and more on the goals and objectives that the that the presidential search committee should be concerned with in seeking a new president for Dartmouth College by June 30, 2023, the date of President Hanlon announced resignation date.

Unfortunately, approximately only 40-43 alumni participated in the second and most recent alumni session with two trustee members of the search committee (Ellie Loughlin '89 and Jeff Crowe '78) and the sole non-trustee alumni member of the search committee (Hilary Johnson '15). The session was congenial, and the panelists appeared willing to listen to the alumni/ae attending the sessions.

Two significant questions brought up by the search committee members attending the March 9th session with the alumni attending the session were as follows:

- What are the challenges and opportunities for a new president of Dartmouth?
- What should the search committee look for in a new president of Dartmouth?

Maynard noted that the two designated alumni from each class will merely be advisory and will not be part of the actual 18-person search committee comprised of Dartmouth trusties, faculty, administrators, some undergraduate and graduate students at Dartmouth, and some alumni (mostly from the existing Board of Trustees).

(Vic noted subsequently that the presidential search committee consists of 18 members: 7 alumni trustee members, 7 members of the faculty from both the undergraduate and graduate schools, 1 non-trustee alumni member, 1 member from the administration, 1 undergraduate school member, 1 graduate/professional school member.)

Attached to this report and an integral part thereof is the *Proposed Selection Criteria for a New President of Dartmouth College* (Draft #2), which was drafted initially by Vic and Don and subsequently revised and amended based on additions and revisions recommended during the discussions of the special class officers/executive committee virtual teleconference held on April 5, 2022.

Maynard adjourned the meeting at 4 PM (EDT).

 - 3. ABILITY TO COMMUNICATE EFFECTIVELY AND ON A REGULAR BASIS WITH THE D FACULTY, STUDENTS, ADMINISTRATION, AND ALUMNI.
 - 4. DURING THE SEARCH FOR A NEW COLLEGE PRESIDENT, THE SEARCH COMMITTEE SHOULD CONSIDER ASKING ASSORTED QUESTIONS OF EACH APPLICANT, CERTAINLY DURING THE EARLY SEGMENTS OF EACH SEARCH.
