## WENDY SKELTON SHARES HIGHS AND LOWS OF MARRIAGE LAW CHANGES

In the following article, reprinted with permissionon from the November 2008 issue of Green Light, the DGALA newsletter, Wendy Skelton '99 reflects on her experience with gay marriage in Massachusetts.

Sarah and I met in college my junior year in 1998. She was the freshman thrower on the track team with me and the coach asked me to look after the new throwers. I started hanging out with her and others and in a short time developed an intimate friendship with her. We would spend hours walking around Occom pond at night and sitting on the golf course looking at the stars. Our relationship slowly blossomed from those walks, and it was touch and go at first as this was my first serious relationship and Sarah would argue that she came to Dartmouth to stay in the closet. We spent the better part of a year helping one another through the muddy waters of coming out and forming new identities.

After college, I followed Sarah to Nebraska for graduate school. This was the first step of commitment in our relationship, to follow her into the Bible belt of the country. We spent five years there, both away from family and friends, both under the pressures of graduate school, and both being publicly out from the start. Those five years allowed us to mature our relationship, to learn to really trust and depend on one another, and to explore how others in the world viewed our relationship. It was the last year of this time that we started to think about getting married. Massachusetts had recently legalized same-sex marriage and we felt as though we had a model, a reality for the next step in our relationship. We had also both attended the Nebraska Symposium on Motivation where Esther Rothblum had presented her research on civil unions in VT. She discovered such things as, after having a civil union, a spouse

was more likely to be addressed on Christmas cards, and that both the spouse and the in-laws reported viewing each other more positively. I'm summarizing some of the results to the best of my memory. Having spent years with my family introducing Sarah as my friend and having difficulty myself feeling recognized in Sarah's family, this research made an impact on our attitudes towards the importance of getting married.

We started to plan our wedding in the Berkshires of MA, with the intention of becoming residents in the near future. Sarah needed to complete an internship for her PhD and chose a program in Seattle. We then realized that we would actually not be getting legally married in MA at the time of the wedding (as we were non-residents at that time), but we continued with the plans anyway. We were married June 10, 2006 after 8 years together, surrounded by about 70 of our friends and family. This was the first same-sex wedding for most of them. Immediately, we started to recognize how much this public display of commitment had changed our relationship in the eyes of some family and friends. My brother, who nearly didn't come, stated that he was amazed at how many people I had in my life that were good people who loved me. He was amazed to know that some guests were gay and some were straight and that he couldn't tell the difference. His long held negative and stereotypical beliefs about gay people were shattered and he was having to reform those beliefs. Most of the people there didn't know that the wedding wasn't legal. We didn't tell them. It was easy to see that some people who

didn't necessarily fully support same-sex marriage, the structure of law, as a normalizing agent. They could accept and understand our relationship better viewing it in familiar terms, legal wedding. This was obviously not necessary for many of our guests but served to be important for several family members.

We moved to Boston in July 2007 and were legally married August 27, 2007. Sarah's brother and wife served as witnesses for us at the courthouse. It was a 15-minute event, 10 of which the justice of the peace used to tell us about her personal transition from not supporting same-sex marriage to understanding the importance of it. We went out for lunch in the North End and celebrated with Italian pastries. The actual step of getting legally married was an odd one for us. We had already had a wedding, and it had served the purpose of bringing together our families. We had already committed to each other for life. Of course we recognized the legal protections this new step afforded us and were very grateful to have them. We felt the importance of being a part of history and felt grateful for those who fought before us for these rights. We felt a little angry that something that could be attained so easily, in 15 minutes, could be so hurtful when withheld from a aroup.

Most of all though, we finally felt the empowerment that comes with legitimacy given by a society, in this case in the form of law. There is no more hesitation at introducing Sarah as my wife and there is no more doubt that anything short of legalized marriage is enough.

to Boston in conjunction with the City of Boston, the NEXUS Green Building Resource Center, Hyatt Regency Boston, and New Ecology, Inc. The students' summer-long project, dubbed "The Big Green Bus," began in Hanover, NH and consisted of a 12,000 mile road trip across America, ending in Boston.

As indicated by the name, the students traveled in a 1970's school bus that had been converted to run on Waste Vegetable Oil (WVO). The students designed the fuel delivery system at Dartmouth's Thayer School of Engineering prior to embarking on their journey. They also stayed continuously connected via cell phones and laptops powered by a series of 250 watt rooftop solar panels and a portable, pole-mounted wind turbine.

We concluded the 197th meeting of the Alumni Council in December, which was an informative and lively meeting. As a reminder, once my term ends there will be a representative for each of our classes. We were on campus during the middle of reading period, so the campus was a bit quieter than the Spring meeting (overlapping with Green Key), but it did provide the unique experience of serving a midnight finals breakfast in Thayer. The Christmas Tree was lit on the Green, which provided a beautiful backdrop to the Aires singing carols and Dartmouth classics at the Hanover Inn. President Wright addressed the Council at dinner Saturday, noting, among other things, that 14 percent of the entering Class of 2012 are first-generation college students and 8.5 percent are international students.
