

CLASS OF 1999 SURVEY REPORT



In late January and early February, 245 of the 997 classmates (24.5%) for whom we had valid e-mail addresses completed an online class survey created by the class Executive Committee. We created this survey because we wanted to better inform ourselves about how our current activities are perceived and how we can better serve you in the future. Our efforts are to benefit you, the Class of 1999 and the College community at large. We want to ensure that we maximize our time and money, and provide services that are both meaningful and desirable.

Thanks to those of you who took the time to complete the survey! We appreciate your frank assessment of our efforts. As the Executive Committee begins the planning process for the next fiscal year, we will take your opinions into account as we set our direction for the class. While we had a relatively high response rate of 24.5%, we recognize that it may not be entirely representative and was most likely answered by those classmates who are at either end of the spectrum: extremely pleased or extremely dissatisfied with the direction of the class.

We've included a brief overview of the survey results on this and the following page. A slightly expanded version is available for download from the class website.

Many thanks to the Class Survey Committee—Dave Dookeeram, Kevin Findlan, Jeff Fine, Rex Morey, and Tony Perry—for their assistance in preparing the survey and analyzing the data. And thanks again to those classmates who shared their opinions with us.

COMMUNICATIONS

- More than 95% of respondents receive and read our paper newsletters, the most effective means of communication with our classmates.
- 44% of respondents want an emailed link or PDF version of the newsletter, 40% want a print version only.
- Visits to the class website are primarily driven by emails. Nearly half of respondents didn't know a class website existed or have never been to it.
- Monthly or quarterly e-mails from the class executive committee are preferred by survey respondents.
- 80% of respondents have HTML-enabled email functionality; only 25% actually use the Blitzmail application. The majority check this e-mail source daily.

CLASS DUES

- The mailed Dues Letter (65%) and the e-mailed letter (40%) were the top two communications that prompted classmates to pay their dues (people could select more than one).
- The main reason people did not pay their dues was they did not see the value (45%). Several write-in responses indicated classmates did not know how their dues were used. 58% said they would be more likely to pay if they had more information about how their dues were spent.

CLASS PROJECTS

 In terms of class projects to raise funds for Dartmouth, Financial Aid (65% as first choice, 81% as first or second choice) was the most supported option. Community Service was second (21% as first choice, 53% as first or second choice). Academic awards was a distant third (7% as first, 30% as first or second)

MINI-REUNIONS

- 28% of respondents have attended minireunions since graduation, with New York City (31%) and Boston (29%) being the top locations amongst those who attended mini-reunions. A full 72% of respondents have not attended mini-reunions.
- If there were a charge for mini-reunions, respondents indicated they'd be most likely to pay between \$20 and \$30 to attend.
- Friday, Saturday, and Sunday are the best days to hold mini-reunions.


REUNION

- The majority of respondents (65%) indicated they planned to attend reunion in June 2008.
- Respondents overwhelmingly state that they would most likely be persuaded to attend our 10th reunion by the attendance list: the number of other classmates and friends who will be in attendance (53%). Cost, the next most persuasive factor, was cited 12 times.

AWARDS


 Respondents appear to be ambivalent about the creation of an award to recognize classmates (50% undecided). If we were to create an award, respondents prefer that we recognize community service in general.

What is the primary reason you did not pay dues for one or more years? (Check all that apply.)


